

WHAT YOU NEED TO KNOW ABOUT MANDATORY COMMERCIAL RECYCLING & COMPOSTING LAWS

Two laws passed by the California Legislature earlier this decade — AB 341 and AB 1826 — set ambitious goals to reduce statewide solid waste disposal up to 75% by 2020. These two laws target commercial recycling and composting (especially food waste) to achieve this goal.

Good news: it's easy — and in many cases costs nothing extra — to be in compliance. Mill Valley Refuse Service has the programs you need to comply with the law, and in most cases you're already paying for these services. Your trash bill

includes unlimited recycling service and a limited amount of compost service, which can be increased for a charge, if needed. FOOD WASTE—HOW MUCH CAN WE DIVERT RIGHT NOW?

AB 1826 spells out when businesses must subscribe to organics services:

- **January 1, 2017** Businesses that generate 4 cubic yards of organic waste per week must arrange for compost service. Organic waste includes food, landscaping debris and food-soiled paper.
- **January 1, 2019** Businesses that generate 4 cubic yards or more of solid waste per week must arrange for compost service. Solid waste includes any kind of trash.



Most businesses don't fall under the 2017 deadline, but many more will in 2019. Even if you don't, *why wait?* The benefits of composting include preserving landfill space, reducing greenhouse gasses and maybe even lowering your trash bill.

MVRS invites all businesses — no matter what your size or how much organic waste you generate — to call us today. Ask for a representative to visit your site to discuss starting organic waste composting.

You should be able to tell your customers that your food scraps do NOT go into the landfill.

FOOD DONATION

While composting your organics is great, it's even better to get surplus food (including produce, baked goods, dairy that has reached its expiration, packaged goods and meat) into the mouths of those who need it.

WHAT YOU NEED TO KNOW ABOUT

COMMERCIAL RECYCLING

IT'S EASY TO RECYCLE AT YOUR BUSINESS

- Make sure your business has arranged for recycling services.
- Use the list below to help employees learn what items can be recycled.
- Separate recyclable items from trash inside your business.
- Do not bag your recyclable items, instead place loose items in MVRS recycling carts for collection.

Note: Any business or individual may donate, sell and/or otherwise arrange for the pickup of recyclable materials.



PAPER

Advertisements
Brown paper
Brown paper bags
Carbonless paper
Catalogs
Cereal and other food boxes (*remove liners*)
Chipboard
Colored paper
Computer paper
Construction paper
Corrugate cardboard (*flatten and bundle no larger than 4ft square*)
Coupons

Mixed paper

DO NOT INCLUDE

GLASS

Bottles
Brown glass
Clear glass
Green glass
Jars
Please rinse lightly to remove food contamination. Remove lids and caps and toss them in loose so they can be recycled too. No corks.

DO NOT INCLUDE

Ceramics
Pyrex
Stemware or drinking glasses
Light bulbs
Window glass
Mirrors

PLASTIC

All plastic containers labeled 1,2,3,4,5 & 7
Plastic bottles
Soft drink bottles
Water jugs
Please rinse and empty before recycling. No need to remove labels, but do remove caps (because they are made from a different type of plastic than the container), and toss caps in to be recycled too.

DO NOT INCLUDE

Styrofoam
Plastic bags
PVC pipe

METAL

Aerosol cans (*empty*)
Aluminum
Aluminum cans/foil/food containers
Bi-metal cans
Ferrous metal
Metal lids and caps
Metal containers
Paint cans (*dry and empty*)
Tin
Steel cans
Please make sure all cans are completely empty and dry. No need to remove labels.

DO NOT INCLUDE

Scrap metal
Propane tanks
Hangers
Containers with liquid

CONTAMINATION CAN UNDERMINE YOUR BEST RECYCLING EFFORTS

Last year, prices for recyclables plummeted, and there is no recovery in sight. This has created a problem at processing plants—plant workers are no longer tearing open plastic bags full of material as they come across the sorting belts. That means that if your workers carry recyclables outside in a plastic bag and drop the whole bag into your brown cart, it might not get torn open or recycled at all. Instead of spending extra labor time to tear them open, these bags usually end up in the trash.



These photos, taken at a recycling plant this year, show actual contamination in loads collected by Mill Valley Refuse Service.

Don't let good recyclables end up in the trash. **Please train your workers to dump out the loose contents of those plastic bags into your carts** (throw the plastic bags in the trash). That will ensure that your recyclables are actually recycled. Thank you!
